



## RUSSIA'S ELECTIONS: IMPLICATIONS FOR RUSSIAN-LATVIAN RELATIONS IN A WIDER EURO-ATLANTIC CONTEXT

Roundtable Discussion Riga, 18 May 2012 Venue: Hotel Bergs

Parliamentary and presidental elections have taken place in Russia. This has raised the questions whether political and economic agenda of "modernization" supported by the president Dmitri Medvedev may experience major changes and be reduced to purely "bridging the technological gap" agenda. Post-electoral period is also becoming a barometer for a depth and maturity of Russia's democratic system and the soundness of the "social contract" between political elite and society. Moreover, there are both windows of opportunities and concerns pertaining to the prospective Russia's foreign policy. Would the recent Russia's "reset" with the West be sustainable after political changes take place in Russia?

The rapprochement between the Euro-Atlantic community and Russia has clearly contributed to the considerable improvement of political atmosphere in Latvian-Russian relations. The interstate economic relations have been flourishing as a result of mutual willingness to slow down political rhetoric and to accelerate pragmatic, interests-based economic cooperation. However, post-electoral politics both in Latvia and Russia may have implications for the mutual interaction. Latvia's policy towards Russia has until recently been shaped by mixture of security and internal national debates on Russia's image and role in the past and since the beginning of the 1990s. On the other hand, the winner of the Russian presidential elections Vladimir Putin has actively re-launched the idea of integration of neighboring geopolitical space. May this have repercussions for mutual trust and sustainability of positive relationship? What could and should be done to avoid tensions? What role the EU-Russia dialogue may play in sustaining "modernization" and "reset" agendas?
